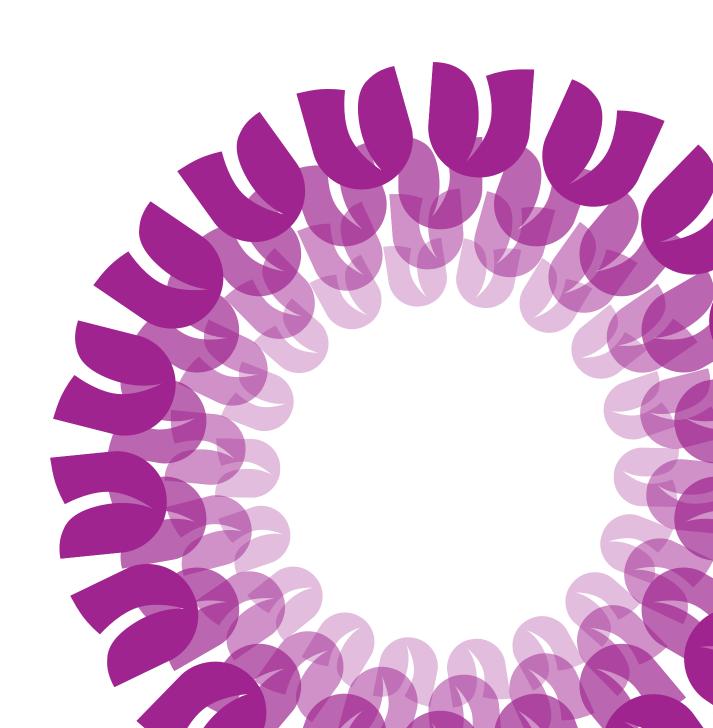

From the CEO, OLIVIA NASSARIS

Strategic review

The 2017/18 financial year has been focused on the future sustainability of Parkinson's SA.

After my appointment as CEO in August 2017 clients, staff and the board contributed to a review of our Strategic Plan and updated our mission: To maximise choice, independence and well-being for people affected by Parkinson's or another movement disorder through support, education and advocacy.

Maximising choice: Everyone's journey with Parkinson's is completely different. One person's choices will be different to someone else. It might be that they choose to stay at home, or choose to live in an aged care facility, choose to go to a support group, or not to.

Maximising independence:

Parkinson's SA is not a charity in the old sense of the word, we don't do things for clients, we do things with clients - we are a support organisation. We encourage people to seek support when they need it, to educate about medication management, treatments, symptom management and we are here to provide that information.

Maximising well-being: We assist clients to maximise well-being. It can be by doing something offered by Parkinson's SA like an art class or carers support group or attending a yoga class. It could also be getting a medication regime right or reducing falls. Whatever it is – choice, independence and well-being are at the heart of what Parkinson's SA offers through support, education and advocacy.

Planning for the future

Another key element of the strategic plan is ensuring the organisation is sustainable into the future, particularly beyond June 2020 when government grants are due to cease. With this

in mind, myself and the Board have been working to re-build the reserves of Parkinson's SA and a move, (just next door) to 25 King William road, that would include a social enterprise project. The project is Brain x Body Fitness Studio, which focuses on active ageing, movement, flexibility and neuroplasticity. Projections show that after a couple of years of operation the business will be able to provide a passive income to support the services provided by Parkinson's SA.

It is with thanks to our first Foundation Partner, Urszula King, that Parkinson's SA was able to begin planning for this project as she generously has donated \$150k rent-free period so that Parkinson's SA can move into the back part of the building next door at 25 King William Road; to enable us to hold bigger seminars on-site and to increase the number of recreational/exercise activities offered to members. Brain x Body Fitness Studio will be situated on the street front of the same building.

The second Foundation Partners of this project is Kevin Weeks and The Weeks Group – who raised \$65k on his bike ride from Adelaide to Rockhampton and is also supporting the fitout of 25 King William Road with staffing and materials.

CMV Foundation is the generous third Foundation Partner who has committed \$150k to the fitout and creation of 25 King William Road.

Staffing & Volunteers

Our team of staff remains committed to delivering quality services. Each individual brings a different skill-set to the team and the amount of goodwill provided by the staff and their families is one of the reasons that Parkinson's SA continues to deliver such a full and rich program.

Each year the activities and services of Parkinson's SA are



supported by our volunteers. Volunteers support us in the office, assist with recreational groups and facilitate support groups both in metro and regional areas – thank you to each and every one for their contribution. I would also like to thank the board members, who also volunteer their time and skill set to ensure Parkinson's SA

Recognising 10 years of service

John Power has recently stepped down as President. He joined the Committee of Management in 2008 and became President in 2010. During this time he has serviced as Chair of the Board, presented countless seminars on his research, attended many support groups, conducted regional visits with Parkinson's SA staff, and was a keynote speaker at the 2015 Parkinson's Australia conference.

Personally, I am very grateful to John for staying on as President when I was appointed to my position. He selflessly delayed his retirement so that he could support the organisation through a period of change. On behalf of the entire Parkinson's community I would like to thank him for his strong leadership, commitment to staff and his heartfelt service to the organisation.

It is once again my privilege to present the Treasurer's report for the financial year ended 30 June 2018.

On the face of it, a shortfall or deficiency of nearly \$80,000 in respect of the 2018 year appears disappointing and concerning, especially in comparison to the \$50,000 surplus in the previous year. The Board were anticipating a tough financial year and had projected a deficiency of approximately \$22,600 before depreciation expenses. The current year results includes depreciation expense of plant and equipment of \$18,292 plus research funding expenditure of just over \$18,000; noting that it has been several years since we invested in a research project.

Grant income shown of \$278,000 does not include \$75,000 worth of grants where we have received the money in advance and have not commenced expenditure under the project (e.g. Perpetual Impact Philanthropy Grant, Stronger Communities, City of Unley PD Warrior and Pop-Up Parkinsons). The grants will be recognised as income when the projects are implemented and the funds expended. This is the first time that the revenue has been deferred in this manner in order to match the timing of the income with the expenditure and whilst is has a one-off negative impact in the 2018 year, we believe it will better reflect the results of the organisation.

Whilst donations and bequests is \$80,000 less than the prior year, 2017 included a couple of significant bequests and the \$164,571 received

in the current year is \$24,000 more than budgeted. Other income is nearly \$28,000 less than last year and \$35,000 less than budgeted, as the staffing structure changes which saw Olivia Nassaris appointed as full-time Chief Executive Officer ("CEO") resulted in Olivia not being available to undertake paid services to Parkinson's Australia, and without these circumstances we would have met budget.

It was also positive to see that membership revenue increased by nearly 50% to just over \$21,000, which is due to the new membership fee structure that has been endorsed by members, as well as a significant increase in member numbers.

Parkinson's South Australia continues to operate on a tight budget. There were some one-off expenditures in relation to the governance expenses and consulting fees that arose due to the changes in the CEO role. In addition, changes in the audit approach resulted in a significant proportion of the current year audit fee being recognised in the 2018 financial year.

Other expenditure increases in the areas of advertising, client support services, printing and stationery relate to the provision of member services and were covered by grant income. Whilst salaries and wages exceeded prior year expenditure, it was \$40,000 less than budgeted due to staffing restructuring without the reduction of member services.

The cash-at-bank and short-term investments is currently just over \$243,000, which on face value may look significant. However, approximately \$142,000 of this has been set aside for grant programs in the 2019 year and the Weeks on Wheels indoor

cycling project of \$65,000. The Board commenced setting aside a percentage of surplus funds on a monthly basis in the 2018 year to boost cash reserves in order to protect the long-term viability of the organisation.

The anticipated changes in the State and Federal Government funding is likely to result in a significant drop in funding in the 2020 and future years; this currently makes up over 30% of the income received by the Association. The Board is continually reviewing, developing and implementing strategies to enable the long-term viability of the organisation in order to be able to continue to provide and expand services to members and the South Australian community. The major project being undertaken in this regard is the Body X Brain Fitness Studio, which has received significant support to date and we believe when it is up and running will support Parkinson's South Australia as a whole.

We look forward to your ongoing support and us continuing to provide improved member services with a broader reach.

From the CLIENT SUPPORT TEAM



The support team over this year consisted of social worker Paula-Jean Hayes (PJ) and registered nurse Jo White, who started in June 2017. This staff combination provided a good skills balance for understanding medical issues and managing personal/relationship/financial/ other challenges in daily life with Parkinson's.

More than 1100 separate counselling/support sessions from the support team were recorded over the 12 months. About 200 of these were first contacts to Parkinson's SA.

Jo and PJ gave information, counselling, advocacy and support chiefly via phone but also through face-to-face meetings. Frequency of home visits was rationalised due to limited resources. However increasingly, email proved useful, as when new clients viewing the PSA website forwarded queries (some wanting to be anonymous).

Others already connected with PSA chose email as convenient, time-flexible, and accommodating of speaking difficulties. Support staff used email more to allow clients to read, digest and keep information for reference, instead of trying to record or remember. Electronic information packs for new clients also saved costs.

People sought help from the support team regarding diagnosis, staying independent, managing symptoms, residential care, respite, relationship changes and for

referral to programs and services. The team provided contacts for appropriate therapists, neurologists and community exercise programs, updating these as required.

Additional calls arose from occasional Parkinson's related media coverage (the article on Light therapy in The Australian was a good example) and the death or diagnosis of celebrity figures (like Neil Diamond and Alan Alda). These promoted conversation and public awareness around the condition.

With the National Disability Insurance Scheme now fully available for under 65s, over 18,000 South Australians are participants.

Those previously receiving supports through Disability SA have been transitioning across to the NDIS, developing individualised plans and putting the Consumer Directed model into operation and support staff assisted when needed.

Others wishing to access the scheme were supported to understand eligibility, navigate steps, provide advice, educate planners on their condition and review unsuccessful applications.

My Aged Care began in 2015 for senior Australians living at home or seeking permanent Aged Care residency. The team continued to inform clients about this system of access.

The shortfall of higher level Home Care Packages available was especially hard for some clients, but the team helped ensure those on long wait-lists gained interim assistance.

Jo continued to deliver the National Parkinson's Aged Care Staff Training package around the state, improving care and outcomes for residents who have Parkinson's.

Groups

At Parkinson's SA, the Support Team links closely with the Group Programs Co-ordinator to serve clients.

Besides personal sessions, PJ and Jo prepared and delivered seminars and addressed community groups, including some Parkinson's support groups.

Small group counselling courses were run by PJ across the year: two for people with Parkinson's (Finding Calm) and two for family carers (Caring with Calm). Using principles from ACT therapy and Mindfulness, participants together learned skills to manage difficult thoughts and feelings.

Support workers facilitated Parkinson's Plus support groups and the Women with Parkinson's group.

The Bereavement gathering initiated last year ran again for those in the Parkinson's community with recently experienced loss; part of our commitment to extend support beyond the death of a significant relative.

Jo co-ordinated 6-weekly meetings of SA's Parkinson's specialist nurses. These offered a valuable forum to discuss practices and innovations, share healthcare news and referral pathways, identify difficulties and enhance medical care for Parkinson's patients.

Stronger ties with Parkinson's nurses improved the capacity for the support team to advocate for clients.

From the GROUP PROGRAMS COORDINATOR



GROUPS

Groups across the state continue to provide valuable information and support, as well as recreational and exercise programs for people affected by Parkinson's. These are facilitated by Parkinson's SA volunteers or staff from various aged care organisations. Of the 29 Support/Education groups there are 6 specialised groups meeting identified needs. These include those with Young onset Parkinson's (20's – 50's group) and those who experience movement disorders other than Parkinson's (e.g, Dystonia, Progressive Supranuclear Palsy, Multiple System Atrophy, Cortico-Basal Degeneration).

The Focus on Family Carers' Group continues to support those caring for a relative with Parkinson's.

The Deep Brain Stimulation group provides a valuable forum for discussion about DBS surgery between those who have undergone the treatment and those considering the surgery.

The Women with Parkinson's group continues to grow and offers a supportive forum for women to share their issues and concerns.

Recreational groups include the weekly Brushlines Art Group, the monthly Photography Group and the Parkinson's Pedallers' Cycling Group. PSA refers clients to five weekly Dance with Parkinson's Groups and a growing number of organisations which provide Parkinson's specific exercise programs.

NEW GROUPS

A new Kingston group was established in response to a local fundraising and awareness raising initiative of Liz Wingard, a younger person living with Parkinson's. Similarly, the local promotion of Regional seminars by Greg Davis on Kangaroo Island, led to the establishment of a group in Kingscote.

Another community fundraising and education event in Gawler by Suzanne Young and Carol Davis has led to the expansion of the local MS group to include people with Parkinson's.

There have been over 20 presentations by Client Services staff to support/education and exercise groups on various topics throughout the year.

GROUP LEADER CHANGES

The passion and commitment of the many group leaders across the state continues to be vital to the effectiveness of groups in meeting the diverse needs of people living with Parkinson's in the community. There have been several leadership changes in the last year.

Julie O'Brien joined the leadership team at Brighton. Liz Wingard offers local support in Kingston.

Kerri Welden and Greg Davis volunteered to lead the newly formed Kingscote Group. Helen Hoppmann invited people with Parkinson's to join a combined MS/Parkinson's group in Gawler.

Margaret Galdies, brought a wealth of knowledge and personal caring experience to her leadership of the Enfield group which closed during the year and has been generous in giving her time to covering other groups where needed.

GROUP LEADERS' SEMINARS

Group leaders participated in three Group Leaders' seminars over the year and had the opportunity to attend the many Parkinson's SA seminars. These are opportunities for group leaders to update their knowledge about relevant issues as well as share ideas about programming and group facilitation strategies.

PROGRAMS FOR FAMILY CARERS

Responding to the needs of family carers continues to be an integral part of the work of the organisation. A range of support and learning opportunities are offered through the monthly Focus on Family Carers' group, Caring with Calm programs, Caring Matters Seminars and special group gatherings for bereaved carers.

The Carers' groups initiated by Brighton and Adelaide Hills groups continue to grow and provide valuable opportunities for mutual support and sharing information.

A Carers' Pampering and Information Day in June this year gathered 35 family carers to acknowledge their important role, offer education in Self Care and an opportunity to take 'time out'.

CREATIVE ARTS PROGRAMS

Living Stories Colourful Lives Project

This year funding from a Community grant from the City of Unley for the Living Stories Colourful Lives Project encompassed tuition from resident artists in various techniques for the Brushlines Art group as well as a facilitator for a 5 week creative writing program. These programs generated inspiring artworks and writings which were exhibited along with the work of the Photography group and other artists and photographers from around the state in the Living Stories Colourful Lives Exhibition during September.



Photography

The Photography group continues to enjoy monthly meetings and outings and plans to recruit new members through a 6 week Intro Photography course in July/August facilitated by Geoff Thompson, an experienced photographer and instructor.

Dance

Dance programs run by qualified dance instructors and based on the Dance for Parkinson's model continue to provide a unique and accessible dance experience and valuable social connection for many people with Parkinson's or other movement disorders and their family members across the state.

REGIONAL OUTREACH

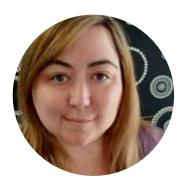
During the year, the Client
Services team has visited groups
and conducted Community
Information seminars, counselling
and professional training in the
Upper South East, Yorke Peninsula,
the Barossa and the Mid-North. In
2018 funding received from the
Department of Communities and
Social Inclusion for the Pop Up
Parkinson's Project expanded the
regional program to include the
Riverland, Barossa, Southern Fleurieu
and Kangaroo Island.

SEMINARS

A total of 45 seminars have been held across the state this year. Parkinson's SA has continued to conduct Understanding Parkinson's seminars in various metropolitan and regional areas, monthly Learn Now Live Well seminars for those with a recent diagnosis of Parkinson's and their family members and Moving Ahead with Parkinson's seminars, with topics relevant to those who have experienced Parkinson's for several years. Special Topics Seminars have covered Parkinson's Plus conditions, Infused therapies, Lewy Body Dementia. Seminars on Medications, NDIS and Employment issues were held for younger people. Funding received through the Continence Foundation of Australia Health Promotion grants led to well attended Bladder and Bowel Health Seminars in the Yorke Peninsula, Murray Mallee/ Adelaide Hills/Southern Fleurieu and metropolitan area.

From FUNDRAISING AND COMMUNICATIONS



Fundraising

A review was undertaken in 2017 of the number of fundraising events that Parkinson's SA organised and participated in to ensure that the return on investment for each event was adequate. This helped to ensure we are obtaining the most from any and all events held, and making sure we are not holding events due to longevity but without fundraising benefit.

A Walk in the Park 2017 was again held at Bonython Park, aiming to decrease unnecessary expenses in the organisation of the event and to increase sponsorship to cover the cost of expenses - thus leaving registrations and fundraising as profit.

The day ran smoothly due largely to the contribution of some wonderful volunteers as well as Parkinson's SA staff. Simon Pilley and Olivia Makrid managed the volunteer input for the day.

As always though weather being the major unknown, the day did have a dampener with drizzle keeping pre-registrations down.

On the day however there were higher registrations largely in part to the West Adelaide Football Club players who joined us on the day supporting Mark Mickan who has recently joined Parkinson's SA after his 2017 diagnosis.

Fundraising from the day and from individual Everyday Hero campaigns raised \$49,850, a \$5000 decrease from the previous year.

Movie nights have proven to be an enjoyable low risk and low cost fundraising event as they also allow the Parkinson's SA community to enjoy socialising.

The Parkinson's SA 2018 Quiz Night was the biggest yet. An astounding 300+ participants filled the Goodwood Community Centre. The event, my first as Fundraising and Communications Coordinator raised over \$14,000 - continuing the success of this fundraising event.

A special thanks to Carolyn Revell who took over the solo role of Quiz Night dream team, collecting silent auction prizes from the local SA community, after her brother Lyndon Radbone passed earlier in 2018.

Our newest event on the calendar, Parkinson's In The Park 2018, proved to be a wonderful addition to the calendar.

After reviewing A Walk In The Park and deciding to shelf the event for 2018. Parkinson's In The Park was added as a new event with a focus on community brand awareness and event visibility.

This inaugural event raising \$11,696 with room to grow in future years thanks to successful grants from City of Unley.

Communications

Intouch has been produced and distributed according to schedule with it's established style guide; shown to receive good feedback issue after issue.

The Parkinson's SA Facebook page has increased significantly in "likes" and reached over 1565 this year. It has continued to be an active medium to advertise events, share relevant news stories and to update the community on the activities of the organisation. A post on August 19 2017, reaching 6381 was by far the largest "reach".

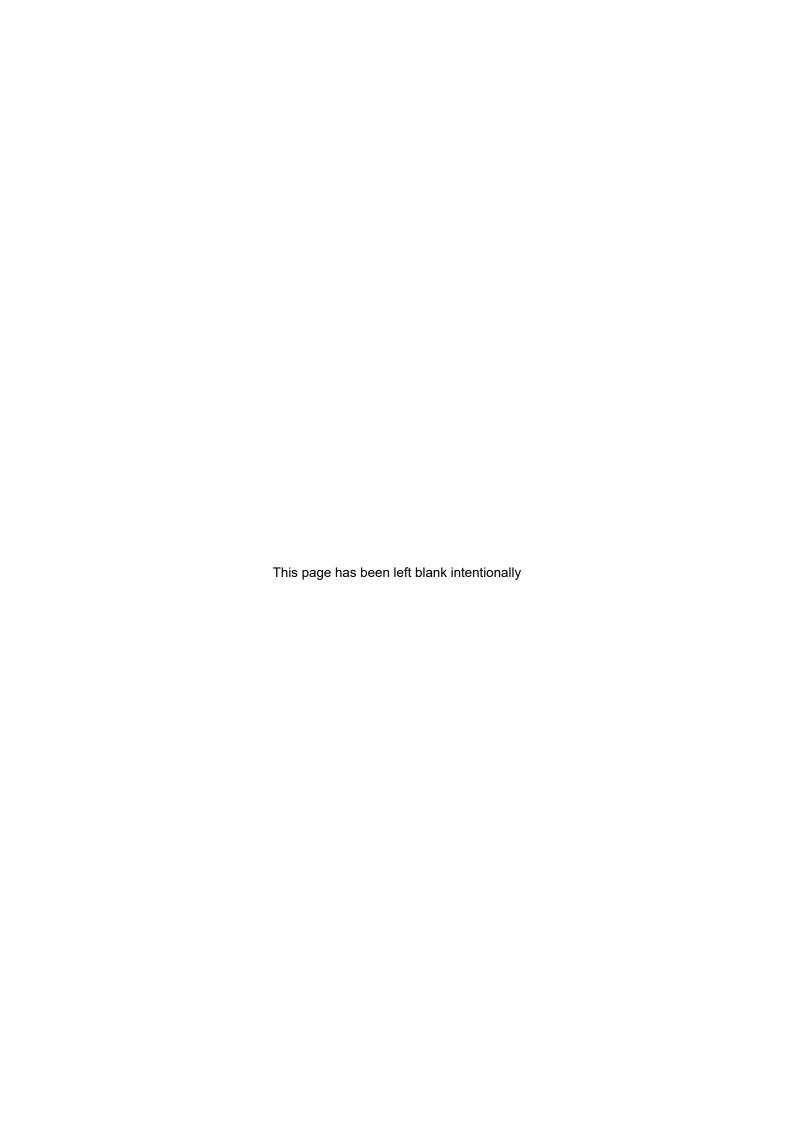
The organic "reach" of our facebook posting average has almost doubled in the past 12 months with an average reach of 310 per post compared to 195 in 2016/17.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2018

1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act (SA) 1985* and the *Australian Charities and Not-for-profits Commission Act 2012*. The board has determined that the Association is not a reporting entity.

The financial statements, except for the cash flow information, have been prepared on a going concern and an accruals basis and are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

a) INCOME TAX

The Association is a charitable non-profit making organisation and as such is exempt from income tax under Section 23 (e) of the Income Tax Assessment Act.

b) PROPERTY, PLANT AND EQUIPMENT

Each class of plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by the Members of the Board to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal.

The depreciable amount of all Plant and Equipment capitalised is depreciated on a straight-line basis over the useful lives of the assets to the Association commencing from the time the asset is held ready for use. The depreciation rates for each class of asset are:

i) Plant and Equipment 20-33%

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the income and expenditure statement.

c) IMPAIRMENT OF ASSETS

At each reporting date, the Association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income and expenditure statement.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2018

1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT)

d) EMPLOYEE BENEFITS

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

A provision for long service leave is recognised by the Association on the commencement of employment, estimated to be payable to employees on the basis of statutory and contractual requirements. A provision is made for 100% of this cost and vested entitlements (employees with more than 7 years service), are classified as current liabilities.

Contributions made to superannuation funds by the Association are charged as an expense when incurred.

e) CASH AND CASH EQUIVALENTS

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

f) REVENUE AND OTHER INCOME

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

Grant monies are brought to account as revenue in the period to which the grant relates.

Fundraising revenue and donations are recognised in the financial year in which they are received. Revenue from subscriptions is recognised in the income statement in the financial year to which the subscription relates.

g) GOODS AND SERVICES TAX (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Statement of Financial Position are shown inclusive of GST.

h) CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

The Board Members evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Association.

i) COMPARATIVE FIGURES

Where necessary, comparative figures have been adjusted to conform with the presentation of the 30 June 2018 financial statements.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2018

1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT)

j) ECONOMIC DEPENDENCY

The Association receives significant funding from Government grants. The extent to which the Association will be able to continue the provision of services at current levels, is dependent on the continuation of appropriate level of Government funding, the achievement of operating surpluses or break even results and positive or break even net operating cash flows.

The Association's recurrent funding agreements are detailed below:

- i) Commonwealth of Australia, Department of Social Services, Specialised Support Services Grant funding agreement for \$145,794 per annum until 30 June 2018.
- ii) Minister for Communites and Social Inclusion funding agreement for \$23,713 per annum until 30 June 2018.
- iii) Commonwealth of Australia, Department of Social Services, Disability and Carer Support Program funding agreement for \$70,609 per annum until 30 June 2018.

k) CONTINGENT LIABILITIES

The Association had no known contingent liabilities as at 30 June 2018.

I) EVENTS AFTER BALANCE SHEET DATE

There have been no significant events that have occurred subsequent to 30 June 2018.
